**Deposit and Payment**

**Golf attire**

The Paa-Ko Ridge Golf Club is a spikeless facility. Metal spikes are not permitted. Proper attire is defined to be regular and customary apparel worn by golfers. Prohibited clothing includes: cut-offs, tank tops, gym shorts, and shoes that cause damage to the greens.

**Terms**

**Cancellation Policy**

Cancellation made more than 1 month in advance - Return of deposit.

Cancellation made from 7 to 30 days in advance- loss of deposit

Cancellation made less than 7 days in advance- loss of deposit and 100% of all charges including green fees, food and beverage, and hire equipment.

**Miscellaneous**

Paa-Ko Ridge Golf Club reserves the right to modify tee times prior to the event date. Regardless of weather, all play is expected to be completed unless the course is declared unplayable and closed by the Golf Course Superintendent.
